

THE COSENER'S HOUSE PRIVACY NOTICE

The Cosener's House is committed to protecting and respecting your privacy. We take your privacy very seriously and we ask that you read this Privacy Notice carefully as it contains important information on:

- a) the personal data we collect about you;
- b) how we look after your personal data when you visit our website (regardless of where you visit from);
- c) with whom your personal data might be shared; and
- d) your privacy rights and how the law protects you.

WHO WE ARE

The Cosener's House is managed by BaxterStorey Limited. BaxterStorey Limited is the controller and responsible for your personal data (collectively referred to as BaxterStorey Limited "we", "us" or "our" in this Privacy Notice).

PERSONAL DATA WHICH WE COLLECT

Personal data provided by you

We collect personal data about you when you:

- (a) contact us through our website;
- (b) post material to our website; and
- (c) provide customer feedback;

The personal data collected in the above manner may include your:

- (a) full name;
- (b) email address;
- (c) telephone number; and
- (d) other information freely provided to us via the text boxes within the forms on our website

Personal data provided by 3rd parties

We may receive information about you from other sources such as Booking.com, Expedia, SiteMinder and OpenTable which we will add to the information we already hold about you in order to help us improve how we carry out any reservations or enquiries made and provide our products and services to you. This may include:

- a) postal address;
- b) [insert any other personal data fields provided to you about the bookings by third parties]; and
- c) Any other information that you provide to third parties for the purpose of fulfilling your booking with us.

Special categories of personal data

We do not proactively collect personal data considered as special category personal data via our website such as health information. However, our website does include text boxes which are designed for you to provide us with certain information and you should be aware that information you freely submit in these boxes may reveal to us certain information that may be considered as special category personal information.

We may ask you to provide us with special category personal data, for example health information such as allergen information or access requirements, so that we can cater appropriately for you and to allow us to facilitate appropriate access to any premises where we are operating. We will only collect your special category personal data with your explicit consent. If we request such information, we will explain why we are requesting it and how we intend to use it.

Personal data about other individuals

If you give us information on behalf of someone else, you confirm that the other person has appointed you to act on his/her behalf and has agreed that you can:

- (a) give consent on his/her behalf to the processing of his/her personal data;
- (b) receive on his/her behalf any data protection notices; and
- (c) give consent to the transfer of his/her personal data outside the European Economic Area.

HOW WE USE YOUR PERSONAL DATA

Overview

We collect information about you so that we can:

- (a) identify you and manage any accounts you hold with us;
- (b) process any orders for goods and/or services which you make with us;
- (c) manage your table bookings and event bookings at our venues;
- (d) assist you with your queries in relation to our business and/or venues;
- (e) analyse your purchasing preferences to provide you with a personalised and memorable experience with us;
- (f) detect and prevent fraud;
- (g) customise our website and its content to your particular preferences;
- (h) notify you of any changes to our website or to our services that may affect you; and
- (i) improve our services.

WHEN WE MIGHT SHARE YOUR PERSONAL DATA WITH THIRD PARTIES

We do not, and will not, sell any of your personal data to any third party - including your name, address, email address or payment card information. We want to earn and maintain your trust, and we believe this is essential in order to do that.

As an essential part of being able to provide our services to you, we do share your data with the following categories of third parties:

- (a) other companies within the BaxterStorey Limited group, as different companies within our group are responsible for different venues;
- (b) service providers that help us to get any purchases which you make through our website to you, such as payment service providers;
- (c) service providers that provide reservation systems for our venues, such as OpenTable, Booking.com, Expedia and SiteMinder;
- (d) service providers that help us to run our business, such as website hosting providers, and website developers,
- (e) professional advisers including lawyers, bankers, auditors and insurers who provide advice to us when we require it;
- (f) law enforcement agencies in connection with any investigation to help prevent unlawful activity;
- (g) third parties to whom we may choose to sell, transfer or merge parts of our business or our assets. Alternatively, we may seek to acquire other businesses or merge with them. If a change happens to our business, then the new owners may use your personal data in the same way as set out in this Privacy Notice; and
- (h) STFC (Science Technology Facilities Council) , for whom we created and manage this website.

We require all third parties to respect the security of your personal data and to treat it in accordance with the law. We do not allow our third-party service providers to use your personal data for their own purposes and only permit them to process your personal data for specified purposes and in accordance with our instructions. If you would like any more information about the third parties which we work with to provide our services to you, please contact us on the contact details provided later in this Privacy Notice.

HOW WE KEEP YOUR PERSONAL DATA SECURE

To protect your information, we have policies and procedures in place to make sure that only authorised personnel can access the information, that information is handled and stored in a secure and sensible manner and all systems that can access the information have the necessary security measures in place.

All employees, contractors and sub-contractors receive the necessary training and resources to ensure they understand their responsibilities in relation to all of our policies and procedures.

In addition to these operational measures we also use a range of technologies and security systems to reinforce the policies and procedures, including ensuring that:

- (a) access to personal data is strictly restricted to those employees who need to access this information as part of their role;
- (b) we store your personal data on secure servers and unauthorised external access to personal data is prevented through the use of a firewall;
- (c) information used for reporting and/or customer profiling purposes is anonymised (so that it does not identify you); and
- (d) payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar (or both) in your browser when we use this technology).

To make sure that these measures are suitable, we run vulnerability tests regularly. Audits to identify areas of weakness and non-compliance are routinely scheduled.

HOW LONG DO WE KEEP YOUR PERSONAL DATA

We shall only retain your information for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting or reporting requirements. If you would like more information about how long we retain specific types of your information, please contact us on the contact details provided later in this Privacy Notice.

TRANSFERS OF YOUR PERSONAL DATA OUT OF THE EEA

All information you provide via our website is stored on our secure servers within the European Economic Area (“EEA”). If any data that we collect from you is transferred to, or stored at, a destination outside the EEA at any time, we will update this Privacy Notice accordingly.

When you link to one of our trusted third party reservation supplier websites via our website or to a social media site via our website, any personal data which you provide them may be transferred or stored outside the EEA. Please check their websites’ privacy notice carefully.

YOUR RIGHTS

The right to access information we hold about you

At any point you can contact us to request the information we hold about you as well as why we have that information, who has access to the information and where we got the information. Once we have received your request we will respond within 30 days.

The right to correct and update the information we hold about you

If the information we hold about you is out of date, incomplete or incorrect, you can inform us and we will ensure that it is updated.

The right to have your information erased

If you feel that we should no longer be using your information or that we are illegally using your information, you can request that we erase the information we hold. When we receive your request, we will confirm whether the information has been deleted or tell you the reason why it cannot be deleted.

The right to object to processing of your information

You have the right to request that we stop processing your information. Upon receiving the request, we will contact you to tell you if we are able to comply or if we have legitimate grounds to continue. If data is no longer processed, we may continue to hold your information to comply with your other rights.

The right to ask us to stop contacting you with direct marketing

You have the right to request that we stop contacting you with direct marketing.

The right to data portability

You have the right to request that we transfer your information to another controller. Once we have received your request, we will comply where it is feasible to do so.

For your security we may need to verify your identity before we process your instructions above.

COOKIES AND TRACKING

Use of cookies

A cookie is a small text file which is placed onto your device when you access our website. We use cookies on this website to:

- (a) recognise you whenever you visit this website (this speeds up your access to the website as you do not have to log in each time);
- (b) obtain information about your preferences, online movements and use of the internet;
- (c) carry out research and statistical analysis to help improve our content, products and services and to help us better understand our customer requirements and interests; and
- (d) make your online experience more efficient and enjoyable.

In most cases we will need your consent in order to use cookies on this website. The exception is where the cookie is essential in order for us to provide you with a product or service you have requested.

Consent to cookies

There is a notice on our home page which describes how we use cookies. If you use this website after this notification has been displayed to you, we will assume that you consent to our use of cookies for the purposes described in this Privacy Notice.
